
Sheffield Resources Limited (“the Company”) (ASX:SFX) has today issued 34,259,421 fully paid ordinary shares at an issue price of \$0.376 per share to YGH Australia Investment Pty Ltd under a placement conducted as part of a transaction also involving an ilmenite offtake and potential joint venture in relation to the Thunderbird Mineral Sands Project disclosed by the Company on 11 August 2020. The placement provides working capital and partially funds early stage development of the Project.
