STANDOUT DRILLING RESULTS EXTEND HIGH GRADE MINERALISATION AT THUNDERBIRD MINERAL SANDS PROJECT

KEY POINTS

- Drilling results outline further extensions to high grade mineralisation at world class
 Thunderbird mineral sands deposit
- The shallow up-dip, high grade mineralised extensions have potential to significantly improve already outstanding project economics
- Resource update work has commenced and is due for completion Q4 2014
- Pre-feasibility Study remains on schedule to be finalised in Q1 2015 and will incorporate the updated resource

Sheffield Resources Limited ("Sheffield" "the Company") (ASX:SFX) today announced further high grade drilling results from its 100% owned Thunderbird Mineral Sands Project, located near Derby in northwest Western Australia.

The results relate to the remaining extensional drill holes from the 2014 aircore drilling program and follow the initial batch of high grade results announced on 17 September 2014. Significant results include:

Up-dip Extension

- 36m @ 10.3% HM from 7.5m (THAC484), including 27m @ 12.6% HM from 10.5m
- 42m @ 8.63% HM from 6m (THAC487), including 27m @ 11.9% HM from 13.5m
- 42m @ 8.46% HM from 12m (THAC486), including 24m @ 12.0% HM from 22.5m
- 39m @ 8.57% HM from 10.5m (THAC488), including 16.5m @ 13.8% HM from 22.5m

Down-dip Infill & Extension

- 60m @ 8.10% HM from 70.5m (THAC505), including 27m @ 11.4% HM from 81m
- **75m @ 6.14% HM** from 64.5m (THAC504), including **27m @ 9.5% HM** from 78m
- **43.5m** @ **9.69% HM** from 76.5m (THAC511)

(>3% HM cut-off, including >7.5% HM cut-off, refer to Table 1 and Appendix 1 for full details).




Figure 1: Plan view of Thunderbird Deposit 32-year pit shell outline on Mineral Resource Classifications showing location of drillholes in this ASX release.




Figure 2: Cross-section F-F' through the Thunderbird deposit showing the resource and 32 year pit shell outline, resource classifications and drill holes in this ASX release.

The results, together with high grade intersections announced on 17 September 2014, show that thick, high grade mineralisation extends well beyond the current resource limits in the updip direction (Figures 1 & 2).

Similarly, the results of down-dip drilling have demonstrate the strong continuity of mineralisation within the part of the resource currently classified as Inferred, and have extended the mineralisation beyond the current resource boundaries (Figures 1 & 2, ASX release dated 14 April, 2014 and 17 September, 2014).

All results are outside the 32-year life-of-mine (LOM) optimised pit shell used in the April 2014 Scoping Study, and therefore have potential to improve the project's already outstanding economics.

Sheffield's Managing Director Bruce McQuitty said: "These are another excellent set of drill results from Thunderbird.

"The discovery of additional high grade mineralisation in the up-dip region is particularly significant because our Scoping Study delivered higher margins in early production years by incorporating similar high grade mineralisation in adjacent areas.

"This latest discovery is just one of several value enhancement opportunities we are investigating during the pre-feasibility stage. We look forward to delivering the next milestones which are the resource update and Pre-feasibility Study results."

Thunderbird has total mineral resources of **2.62Bt @ 6.5% HM** (Measured, Indicated and Inferred) for **170Mt of contained HM**, including a high grade component of **740Mt @ 12.1% HM** (see full resources tabulation Appendix 2 and ASX release dated 19 March 2014).

The Thunderbird Scoping Study, released on 14 April 2014, showed the project has the potential to generate consistently strong cash margins from globally significant levels of production over an initial 32-year mine life.

All drilling and field-based pre-feasibility activities are now complete for 2014. In total, 119 aircore drill holes for 7,644m were completed at Thunderbird and 61 aircore drill holes for 3,081m completed on regional exploration targets. Other field activities included the drilling of 20 sonic drill core holes (total 781m) for geotechnical information, and the drilling and pump testing of three full-sized production water bores (total 294m) for hydrological studies.

Results from infill aircore drilling at Thunderbird and regional exploration drilling are expected to be received during Q4 2014 and Q1 2015, respectively.

Pre-feasibility work is well advanced and is on schedule to be finalised during Q1 2015.

EXPLORATION RESULTS

SCOPING STUDY
